



Terms and Conditions

1. RENTAL PERIOD: 7 day minimum from May 1st till October 1st. A 3 day minimum from October 2nd till April 30. Pickup time is between 8am and noon, and return time is 1pm and 4pm **SHARP!** The renter will be charged \$25. per hour for a vehicle returned late and 1.5 the daily rental rate for each day the vehicle is late.

REMEMBER –Other people may be waiting for the vehicle. Please contact our office if you are going to be delayed. No vehicle may be picked up or returned on Saturday or Sunday.

2. RESERVATION DEPOSIT: Required on all rentals is a \$500.00 hold deposit. 2 months prior to your departure the full remaining balance will be charged.

THE RESERVATION DEPOSIT/ FULL PAYMENT IS NOT REFUNDABLE AT ANY TIME.

3. SECURITY DEPOSIT: \$1000.00 required at time of departure. Refundable within 5 business days of return providing the vehicle is clean (inside and outside), holding tanks are empty, gas and propane are full and the vehicle is not damaged or abused.

4. CLEANING CHARGE: A \$100.00 charge will be applied if the unit is returned and not clean, this charge will be at the discretion of a Destinations RV Rentals employee.

5. GASOLINE AND PROPANE TANKS are released full and must be returned full. If not, the renter will be charged a \$50.00 service charge to fill the gasoline tank plus the cost of gas at \$4.00 per gallon. A \$50.00 service charge will also be levied to fill the propane plus the cost of propane at \$4.00 per gallon.

6. DUMP FEE: A fee of \$150.00 will be charged if the holding tanks are not empty upon return.

7. PET FEE: A \$50.00 sanitation fee will be charged for pets.

8. WINTERIZING FEE: Required on all winter rentals. This fee is not refundable. This will be in the amount of \$75.00 applied when the vehicle is returned.

9. PAYMENT: All fees are payable by **A MAJOR CREDIT CARD (MASTERCARD OR VISA)**. **WE DO NOT ACCEPT PERSONAL CHECKS.** Full payment is due 2 months before departure. Security deposits, estimated mileage charge, insurance waiver, winterizing fee, etc. will be charged at time of departure. If the final payment is made on MasterCard or Visa arrangements must be made prior to day of departure.

10. BREAKDOWNS: If breakdowns occur and repairs are needed: Any repair under \$250 may be done. Any repair over \$250 must have prior authorization from Destinations RV. Please save and submit all receipts for repairs. **Refunds will not be made without a receipt.**

11. ACCIDENT: If involved in an accident you must notify dealer within 24 hours. A full written police accident report must be submitted to our management upon your return. Failure to comply will result in the forfeiture of your security deposit.

12. IDENTIFICATION: Proper identification, employment, credit references, and a valid drivers license must be presented when reserving a vehicle. **ALL INFORMATION WILL BE VERIFIED.**

13. ALL DRIVERS MUST BE 25 YEARS OF AGE.

14. Complete operating instructions will be given at time of departure. It will take approximately 45 minutes to one hour. A more convenient time may be scheduled.

15. We reserve the right to refuse any applicant.
